❖ Court Reporter Course is a 7-week course that provides provides Paralegal Specialists with the training necessary to perform Court Reporter duties. The course focuses on essential voice writing techniques, speech recognition, and court reporter training for Army Paralegal NCOs and Paralegal Specialists. Those attending the Basic Court Reporter Course must complete the Court Reporter Candidate Course through JAGU (www.jagu.army.mil) prior to attendance.

* Advanced Court Reporter Course is a

4 ½ day course that provides training and procedural guidance to government court reporters, as well as to adopt best practices. Further, this course will prepare court reporters for higher leadership positions by incorporating instruction for the development and training of court reporters within their jurisdiction. This will enable the students to grow and mentor less-experienced personnel, while assisting their respective Office of the Staff Judge Advocate in processing records of trial and post-trial actions. This course is geared towards SGT-SSG (E5-E6). The course is held annually.


