Who (Prerequisites): Successfully completed Advanced Individual Training (AIT) and served in the unit a minimum of one year after completion of AIT. Soldiers that re-class into the MOS 27D may take this course immediately after completion of AIT. An exception to policy may be requested through TDD if a need arises to take this course outside of these circumstances.

Where (Location/enrollment): To enroll in APCC, students must complete the ATRRS Registration Form found on Training Resources, and Publications (TRP) at <a href="https://tjaglcs.army.mil/studentservices">https://tjaglcs.army.mil/studentservices</a> or on JAGU at <a href="https://jagu.llc.army.mil">https://jagu.llc.army.mil</a>. Why (Readiness): APCC consists of five modules and 26 lessons. In this course, students gain a solid foundation in the law and paralegal profession through an interactive online learning platform focusing on effective legal writing, client services, administrative law, military justice, national security law, and fiscal law. APCC provides knowledge that increases critical reasoning skills and aids creative thinking skills. This course bridges the learning gap between paralegals AIT and Advance Leaders Course (ALC).
