1. (U) SITUATION.

1.A. (U) DODI 1300.17 (REFERENCE A) DIRECTS THE MILITARY SERVICES TO
EDUCATE AND TRAIN COMMANDERS, JUDGE ADVOCATES, CHAPLAINS, RECRUITERS,
AND OTHER PERSONNEL AS DEEMED APPROPRIATE ON THE POLICIES AND
PROCEDURES PERTAINING TO THE ACCOMMODATION OF RELIGIOUS PRACTICES.
RELIGIOUS ACCOMMODATION (RA) TRAINING WILL INCLUDE INSTRUCTION
REGARDING NEW DODI 1300.17 PROCESSING TIMELINES FOR ACTIONS ON
RELIGIOUS ACCOMMODATION REQUESTS. REQUESTS ORIGINATING FROM WITHIN
THE UNITED STATES, THAT CAN BE APPROVED CONSISTENT WITH EXISTING ARMY
POLICIES AND REGULATIONS MUST BE COMPLETED AND WRITTEN NOTIFICATION
PROVIDED TO THE SOLDIER NLT 30 DAYS FROM THE SOLDIER'S SUBMISSION.

FOR REQUESTS OUTSIDE OF THE UNITED STATES OR FOR RESERVE COMPONENT SOLDIERS NOT ON ACTIVE DUTY, RELIGIOUS ACCOMMODATION REQUESTS MUST BE COMPLETED NLT 60 DAYS FROM SOLDIER'S SUBMISSION.

1.B. (U) AR 600-20 SUPERSEDES ALL PRIOR ARMY DIRECTIVES AND ALARACTS ON RELIGIOUS ACCOMMODATION AND CONSOLIDATES EXISTING RELIGIOUS ACCOMMODATION STANDARDS, WHICH ARE IAW THE RELIGIOUS FREEDOM RESTORATION ACT (42 U.S.C. CHAPTER 42).

1.C. (U) AR 600-20 DIRECTS THE OFFICE OF THE CHIEF OF CHAPLAINS (OCCH) TO DEVELOP AND PUBLISH TRAINING ON THE POLICIES AND PROCEDURES FOR REQUESTING AND RECEIVING RELIGIOUS ACCOMMODATION.

2. (U) MISSION. EFFECTIVE IMMEDIATELY, SENIOR CHAPLAIN CORPS LEADERS TRAIN COMMANDERS, SELECT STAFF WITHIN THEIR ORGANIZATIONS, INCLUDING JUDGE ADVOCATES, ON THE REVISED AR 600-20 POLICIES AND PROCEDURES FOR RECEIVING RELIGIOUS ACCOMMODATION (RA) REQUESTS RELATED TO RELIGIOUS LIBERTY (RL) AND FIRST AMENDMENT RELIGIOUS FREEDOMS OF ARMY PERSONNEL.

3. (U) EXECUTION.

3.A. (U) INTENT/ENDSTATE. COMMANDERS AND SELECT STAFF UNDERSTAND AND ARE PREPARED TO EXECUTE COMMAND RESPONSIBILITY TO RECEIVE, PROCESS, AND/OR SUPPORT RELIGIOUS ACCOMMODATION REQUESTS RELATED TO RELIGIOUS LIBERTY AND FIRST AMENDMENT RELIGIOUS FREEDOMS FROM ARMY PERSONNEL AND PRE-ACCESSION CANDIDATES. COMMANDERS, CHAPLAINS, JUDGE ADVOCATES, AND RECRUITERS ARE TRAINED ON THE POLICIES AND PROCEDURES PERTAINING TO THE ACCOMMODATION OF RELIGIOUS PRACTICES IN THE ARMY.

3.B. (U) CONCEPT OF OPERATIONS.

3.B.1. (U) PHASE ONE. THE OFFICE OF THE CHIEF OF CHAPLAINS (OCCH) MOBILE TRAINING TEAM (MTT) AND/OR SUPERVISORY CHAPLAINS, WITH JUDGE ADVOCATE SUPPORT, AS NEEDED, TRAIN CHAPLAIN CORPS AND JUDGE ADVOCATE PERSONNEL ON RELIGIOUS ACCOMMODATION POLICIES AND PROCEDURES. TRAINING INCLUDES CONCISE VERSION OF TRAINING FOR USE DURING PHASE TWO. ACTIVE COMPONENT COMPLETES PHASE ONE TRAINING NLT 30 JANUARY 2021. USAR/ARNG COMPLETES PHASE ONE TRAINING NLT 30 JUNE 2021.

3.B.2. (U) PHASE TWO. SUPERVISORY CHAPLAINS (AT BRIGADE AND ABOVE) WITH JUDGE ADVOCATE SUPPORT USE CONCISE VERSION OF TRAINING TO TRAIN BDE/BN COMMANDERS AND COMMAND SERGEANTS MAJOR ON RA POLICIES AND PROCEDURES. ACTIVE COMPONENT COMPLETES PHASE TWO TRAINING NLT 30 JUNE 2021. USAR/ARNG COMPLETES PHASE TWO TRAINING NLT 31 DECEMBER 2021.

3.B.3. (U) PHASE THREE. SENIOR COMMANDERS AT ARMY AND JOINT BASE INSTALLATIONS ENSURE TRAINING ON RELIGIOUS ACCOMMODATION POLICIES AND PROCEDURES IS INCORPORATED IN PRE-COMMAND TRAINING PROVIDED TO COMPANY COMMANDERS AND FIRST SERGEANTS. ACTIVE COMPONENT COMPLETES PHASE THREE NLT 31 DECEMBER 2021. USAR/ARNG COMPLETES PHASE THREE NLT 30 SEPTEMBER 2022. RELIGIOUS ACCOMMODATION TRAINING IS INCORPORATED IN THE PRE-COMMAND COURSE TRAINING PROVIDED TO BATTALION AND BRIGADE COMMANDERS.

3.C. (U) TASKS TO ARMY STAFF, SUBORDINATE UNITS AND REQUESTS FOR SUPPORT.

3.C.1. (U) OFFICE OF THE CHIEF OF CHAPLAINS (OCCH).
