### OSJA-OSTC Training

CLD led webinars will continue to run approximately once a month through September. These webinars will lay the foundations of critical changes to our military justice practice. Details of each webinar are shared with your offices through CLD's MJ-NEXT Sends. The next webinar will be on 31 May at 1300 EST through <u>this MS Teams link</u> and will discuss the relationship between covered offenses, nonjudicial punishment, and administrative actions. #### **USARC Command Legal Advisors Course – 7-9 June 2023**

The U.S. Army Reserve Command OSJA will host the Command Legal Advisor Course from 7-9 June 2023 at Fort Liberty, NC. This course fills a critical training gap for Judge Advocates in the USAR to prepare them for assignment in embedded positions at the Brigade, Division, and Command levels. Subject Matter Experts will train Army Reserve legal advisors on current law, policy, doctrinal guidance, and standard operating procedures to support USAR Commanders in maintaining good order and discipline and building legal readiness. #### Solution State State

This course focuses on more complex legal principles and practical skills for Army Paralegals, both military and civilian, within the core practice areas of the Judge Advocate General's Corps (JAGC). Additionally, the course emphasizes leadership and management techniques and best practices within those legal practice areas, as well as the more nuanced understanding of law and policy required at Corps and higher levels of command. #### 874th Basic Court Reporter Course – 10 July – 25 August 2023

This course provides Paralegal Specialists with the training necessary to perform Court Reporter duties. The course focuses on essential Eclipse editing techniques and court reporter training for Army Paralegal NCOs and Paralegal Specialists. Included in the curriculum are the following topics: Eclipse; basics of court reporting (grammar and proofreading); court-martial terminology; stages of trial; courtroom management; verbatim records of trial, Military Justice Online, post-trial, and preparation of records of trial. ## I76th Contract Attorneys Course – 18-28 July 2023

This two-week course provides foundational instruction in federal government contract law for entry-level U.S. government attorneys at installations, Army Materiel Command, and comparable contracting activities. It covers the statutory, regulatory, and policy authorities applicable to government contract law, including the Federal Acquisition Regulation, authority to bind the government, contract formation, contract administration, bid protests, and contract disputes. # Basic Environmental Law Course – 24–28 July 2023
