Managing Interrogation Detention Operations Training (MI-DOT)

Applications to attend Managing Interrogation Detention Operations Training (MIDOT) from 8-10 September 2023 at the Army Advocacy Center, Fort Belvoir, Virginia are now open. The shift from COIN to training for large-scale combat operations heightens the need to ensure Army personnel are ready to support military interrogation operations. Hosted by the Military Intelligence Readiness Command (MIRC), Legal Command, U.S. Army Intelligence & Security Command, and HUMIT Training – Joint Center of Excellence (HT-JCOE) with input from 200th Military Police Command, MIDOT is a three-day overview course on interrogation operations/detention operations for attorneys, interrogators, and MPs. INSCOM OSJA, 200th MP Command, and HT-JCOE subject matter experts will provide UNCLASS-level training on planning for legal and ethical detention and interrogation operations. Attendance is by invitation only based on an application, with prioritization given to personnel assigned to units with interrogation or detention operations missions.
