MEMORANDUM FOR Judge Advocate Officer Basic Course Students, The Judge Advocate General's Legal Center and School, Charlottesville, VA 22903

SUBJECT: Policy Memorandum # 02-23, Housing Policy

1. All Judge Advocate Officer Basic Course (JAOBC) students will reside in Army Lodging at The Judge Advocate General's Legal Center and School (TJAGLCS) while attending JA OBC in Charlottesville.
2. If the class size exceeds the number of available rooms, the Student Detachment Cadre, in conjunction with Army Lodging personnel, will make alternate lodging arrangements at the Sonesta or similar hotel. At no time will a student make their own lodging arrangements for JA OBC.
3. All students will be housed in a standard room at TJAGLCS or a studio room at the Sonesta. The maximum occupancy for these rooms is two adults. A limited number of junior suites are available at TJAGLCS with a maximum occupancy of four adults. Junior suites, if available, will be provided to students based on family size and special circumstances, which must be annotated on the JA OBC in-processing sheet. Any charges incurred for additional occupants in the room are non-reimbursable and the responsibility of the student.
4. Exceptions to this policy will be considered on a case-by-case basis. An exception to policy memorandum must be forwarded through the Student Detachment Executive Officer prior to week five of the Direct Commission Course. The Student Detachment Commander is the final approval authority for exceptions to this policy.
